## **ALARM PERMIT FEES**

The City of Adams establishes the following fees for permits:

TYPE OF PERMIT

RESIDENTIAL \$5 (ANNUAL FEE)

COMMERCIAL \$5 (ANNUAL FEE)

GOVERNMENT NO FEE

The permit holder is responsible to immediately report any changes in address, phone numbers, or key holders to the Adams Police Department and monitoring agency.

## **FALSE ALARM FEES**

City of Adams establishes the following fees for false alarms. Fees must be paid before a permit can be issued.

NO PERMIT: \$200.50 for each un-permitted burglary alarm.

ROBBERY, BURGLARY: (Includes panic and duress alarms) There is no service fee for the first two false alarms. A \$25 service fee for the 3<sup>rd</sup> false alarm, \$35 service fee for the 4<sup>th</sup> false alarm, \$45 service fee for the 5<sup>th</sup> false alarm and a \$65 service fee for the 6<sup>th</sup> and all subsequent false alarms within a calendar year.

FIRE: There is no service fee for the first two false alarms.

\$100 for the 3<sup>rd</sup> and all subsequent false alarms within the calendar year.

## **ADDITIONAL INFORMATION**

Failure to have a valid alarm permit can result in fines of \$200.50 for each false alarm.

Alarm sites with local alarm systems (non-monitored) are required to have a valid alarm system permit.
