

RESOLUTION NO. 2024-13R

Sec. 2-2-19 of the City Code of Ordinance: Fees From time to time, the Common Council may, by resolution, impose and revise the fees for permits, fines and licenses issued by the City and other charges imposed by the City. Resolutions which impose or revise fees or charges shall first be approved by the Finance Committee of the Common Council.

WHEREAS, said Resolution 2024-05R by the City of Adams, Adams County, Wisconsin authorize fees to be charged; and,

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF ADAMS, WISCONSIN, that fines will be charged for violations of the Code of Ordinances, plus court costs for said violations as follows:



